I agree in consideration for my participation in the Luna Tunes Freestyles Clinic by Cynthia Collins to the following:

I agree that I choose to participate voluntarily in the Clinic with my horse and/or any other horse as a rider. I am fully aware and acknowledge that the use, handling, and riding of a horse involves risk of serious physical injury or death to any individual undertaking such activities, and that a horse, irrespective of its training and usual behavior and characteristics, may act or react unpredictably at times based on instinct or fright which, likewise, is an inherent risk assumed by a horseback rider. With full understanding of these risks, on behalf of myself and any of my minor children participating, I hereby voluntarily assume these risks.

I agree to release Cynthia and Terrence Collins and Luna Tunes Freestyles of and from any and all liability whatsoever for any personal injury, death, property damages, and from all claims for money damages or otherwise Harm to me, my participating minor children, or my horse and/or any other horse ridden by myself and/or my minor children, for any Harm caused by me, my minor children, or horse to others, even if the Harm resulted, directly or indirectly, from the negligence of Cynthia and/or Terrence Collins and Luna Tunes Freestyles.

On behalf of myself and my minor children, my guests or visitors, I voluntarily wave and relinquish any and all present and future claims for ordinary negligence, pain and suffering, wrongful death, or breach of warranty, arising directly or indirectly from participation by me and my minor children in any activities associated with the use, handling, or riding of a horse in this Clinic.

I agree to indemnify, release, and hold harmless Cynthia and Terrence Collins and Luna Tunes Freestyles of any and all liability whatsoever for third party use of any and all music, including audiovisual, and agree to be responsible for paying any and all fees and obtaining all rights of music and accept all liability of all penalties for such use.

I agree to protect, hold harmless with respect to claims for Harm to me, my minor children, or my horse and/or any other horse ridden by myself and/or minor children and indemnify released parties of and from all costs, medical expenses, attorney's fees, claims, demands, lawsuits or other monetary damages incurred by or assessed against released parties arising in any way from use, handling, or riding of a horse and for any claims made by others for any Harm caused by me, my minor children or my horse or horse ridden, at the Clinic.

I agree to WEAR PROTECTIVE HEADGEAR and proper footwear at ALL TIMES when myself and my minor children are mounted on my or any other horse at the Clinic.

I acknowledge that the terms of this release shall be binding upon the heirs, successors, legal representatives and assigns of myself and my minor children.

I HAVE CAREFULLY READ AND UNDERSTAND THIS FULL AND FINAL RELEASE AND SIGN THIS RELEASE VOLUNTARILY AND AGREE TO ALL TERMS AND PROVISIONS OF ITS CONTENTS.
